Facts are, Justin Collin Adams while operating a black in color 2018 Chevrolet Malibu and entered the Sunrise Presbyterian parking lot at a high rate of speed. Once the vehicle entered the parking lot it left the parking lot and entered the school's playground occupied by multiple juveniles. Justin Collin Adams accelerated into the playground in the direction of the juveniles striking a twelve-year juvenile male with the vehicle inflecting injuries to the child who was transported to a local hospital. 


